to Winter Park. The Grand Foundation has granted over \$19.3 million to more than 2,300 qualified Grand County organizations, individuals, and small businesses that provide essential services and programs, touching thousands of lives in Grand County.

## A Note of Reflection from the Director

2020 was a life changing year not only for the Grand Foundation, the Grand County community, but the entire world. 2020 brought us so many challenges, obstacles and successes. The foundation took on COVID-19, the East Troublesome and Williams Fork Fires, all while helping two new counties, Jackson and Clear Creek. We managed all of the CARES dollars for Grand, Clear Creek and Jackson Counties. The annual grants program reached over \$2.4 Million in 2020 and supported nearly 2,300 non-profit organizations, individuals and small businesses. In 2020, the Grand Foundation reached a bittersweet milestone by surpassing \$19 Million mark.

For over 24 years the Grand Foundation has focused on supporting the Grand County Community. Even with this mission nothing could have prepared us for what happened on October 21, 2020 with the East

Troublesome Fire. Within hours, the fire destroyed over 20% of our community's landscape. The outpouring of generosity from around the community, state and the nation filled our shattered hearts with hope and love.

We were and continue to be amazed by the human spirit to give, to care and to support one another. It is how we know we will get through, rebuild and survive this tragedy.

We will be stronger, braver and kinder as a result of it.

Thank you to everyone who has played a role in supporting our community. We are forever grateful.

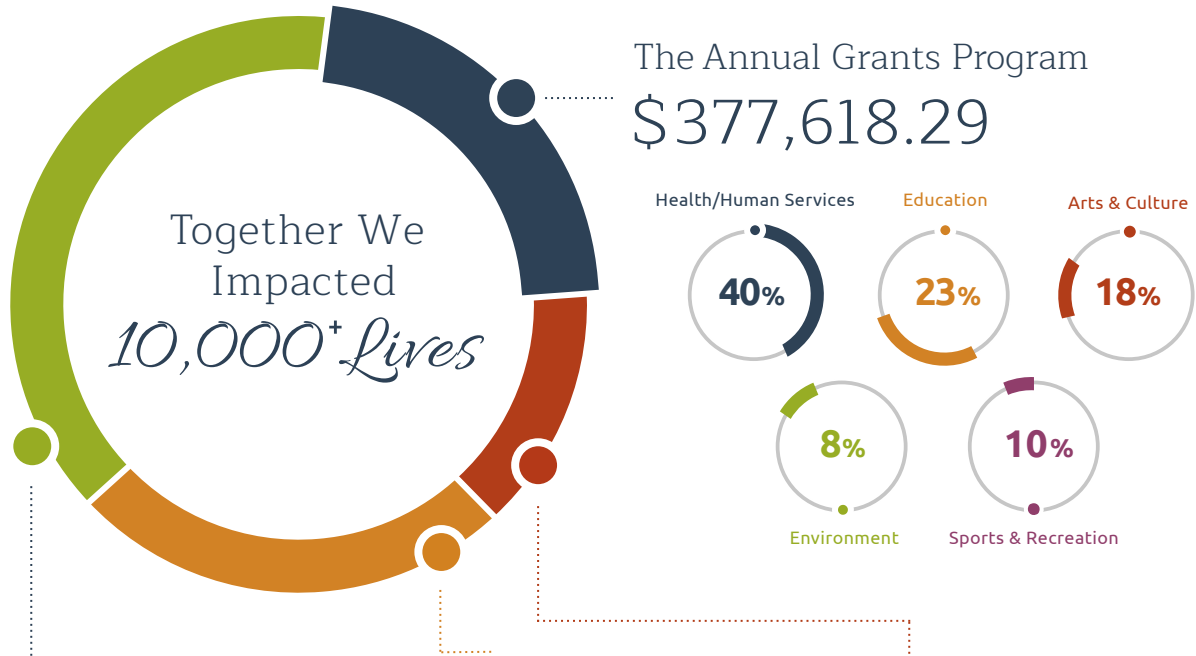

## Hunger Relief, Housing Assistance & More Mountain Family Center

The Grand Foundation has been a proud supporter of Mountain Family Center (MFC) for over 25 years. Mountain Family Center is a community-based nonprofit organization dedicated to building strength and developing self-reliance through responsive and collaborative services. Mountain Family Center's food, housing, financial assistance, and general resource services were essential to the Grand County community in 2020 through the pandemic and wildfire. The Grand Foundation provided funding that allows Mountain Family Center to maintain their children, family, and senior services to fit the increasing need of the community and provide training to their staff regarding supporting families. In addition, the Mountain Family Center and the Grand Foundation's partnership was instrumental in providing emergency relief during 2020.



## Healthier Together Grand County Rural Health Network

The Grand Foundation has been supporting the Grand County Rural Health Network (GCRHN) in its mission to advocate for and support the health of our community for over 20 years. The GCRHN aims to provide affordable, comprehensive health and human services to everyone in the community while improving and sustaining services to underserved populations through an equitable lens. With the support of the Grand Foundation, the Rural Health Network has been able to institute and effectively run the Patient Navigator (PN) Program. This program supports, educates, and empowers clients to become more self-sufficient in managing their health and the aspects of their lives that impact their health. In addition, the Grand Foundation has funded their Aches and Pains and Mental Health Voucher program, which provides vouchers to those who are in need of medical care and mental health services.



## Preventing Forest Fires Grand County Wildfire Council

The Grand County Wildfire Council has evolved into a successful 501(c)(3) organization with many beneficial programs created and executed with the intent of helping Grand County residents and visitors live more safely with the threat of wildfires. The Grand Foundation funded GCWC with seed money to create an identity, design an educational website, and purchase a tent/booth for community events. The Grand Foundation has supported GCWC since 2013, helping the organization engage the public during wildfire season with significant educational information and hazardous fuel mitigation efforts.

## Designated Funds

**A DESIGNATED FUND**, or DF, is a giving vehicle established at a public charity. It is created by the Community Foundation in an attempt to restrict monies to a specific need not being met in the community. This fund allows the foundation to distribute grants from the fund over time. Donors can contribute to the fund as long as they understand and accept the restriction.

### *Our Designated Funds*

#### **East Grand Foundation Education Fund**

The mission of the East Grand Education Foundation Fund is to provide alternative funding for educational opportunities for students enrolled in the East Grand School District.

#### **G.A.P. Fund for Youth**

The G.A.P. Fund was established to provide financial assistance with participation fees for non academic activities to full time resident Grand County youth between the ages of birth and 18 years of age

#### **Brammer Family Fund**

The Brammer Family Fund was established to provide financial assistance to Grand County residents and their families who are affected by cancer.

#### **Grand County Housing Assistance Fund**

The Grand County Housing Assistance Fund is in partnership with the Leadership for a Sustainable Community Committee and aims to help full-time residents successfully live and work in Grand County.

#### **Blue Valley Ranch Youth Fund**

The Blue Valley Ranch Youth Fund was established to provide financial assistance to Grand County youth for education, activities, opportunities, and more.

#### **Middle Park High School Student Philanthropy Fund**

The Middle Park High School Student Philanthropy Fund (MPHS-SPF) is a student run designated fund that supports organizations that enhance the quality of life in Grand County.

#### **Town of Winter Park Housing Assistance Fund**

This fund, in partnership with the Town of Winter Park and Winter Park Resort, aims to provide financial assistance to help full-time residents successfully live and work in the Winter Park and Fraser Valley area.

#### **Grand County Wildfire Assistance Fund**

The Grand County Wildfire Emergency Fund was established to support the needs of Grand County residents who have been evacuated, displaced, or lost their homes during the Grand County Wildfires.

#### **Clear Creek Housing Assistance Fund**

The Clear Creek Housing Assistance Fund was established to assist Clear Creek in managing its CARES dollars for rent and utility assistance.

#### **Small Business Emergency Assistance Fund**

The Small Business Emergency Assistance Fund was established during Covid times to manage the CARES dollars for small businesses for rent, mortgage and utility assistance.

#### **Emergency Assistance Fund**

The Emergency Assistance Fund was established during emergency situations in 2020 to prepare for any future emergencies in the county.

#### **Moffatt Road Railroad Museum**

The Moffat Railroad Museum fund was established to fiscally support the organization until they earned their 501(c)(3).



## Donor-Advised Funds

A **DONOR-ADVISED FUND**, or DAF, is a giving vehicle established at a public charity foundation. It allows donors to make a charitable contribution, receive an immediate tax deduction and then recommend grants from the fund over time. Donors can contribute to the fund as frequently as they like, and then recommend grants to their favorite charities whenever makes sense for them.

### Our Donor-Advised Funds

#### Grand County Commissioners' Fund

Helps primarily non-profit community organizations with funds that provide or enhance residents' access to basic primary needs in health and human services and education.

#### Winter Park Housing Assistance Fund

Offering grants for organizations that enhance the quality of life in Grand County through arts and culture, health and human services, environment, education, or sports.

#### Opportunity for Youth Fund

This fund helps provide financial assistance to young people whose families' financial means do not allow them to pay for activities for which the young person has earned the right to participate

#### Treckles Foundation Fund

Unsolicited private family trust/foundation granting dollars to Grand County organizations.
